# Minutes of committee meeting held on 9th September 2025

#### 1. Welcome

Ann Marie welcomed everyone to the meeting.

### 2. Apologies for absence

Apologies were received from Terry Kendall, Kathie Sharman, Rose Crawley.

# 3. Minutes of the meeting held on 12<sup>th</sup> August 2025

The minutes of the meeting held on 12<sup>th</sup> August 2025 were agreed as a true record.

#### 4. Matters arising

- (a) Terry has now received an email from Alison Lofas regarding the 'Parkinson's qualified instructor'. The brand team have said there is no guidance regarding t-shirts as they are available for anyone to buy but this does not mean endorsement. If the instructor wears one it does not mean that the classes are run by the charity. However, the issue has enabled the brand team to consider including a disclaimer on the PUK shop purchases saying they are not an endorsement.
- (b) No update yet regarding the neurologist clinic at Barnsley hospital.
- (c) PUK are unable to provide funding for the Strolll reality glasses as they have already provided funding for a two-year study being undertaken by Dr. Julie Jones at Glasgow University. Terry is looking into a three-way split between us, Sheffield and PUK but he is still waiting to hear back from Sheffield.
  - (d) No update yet from Sarah Juhasz regarding the volunteering event at Barnsley College. Ken clarified that he wanted someone to take over the website rather than help him with it.
  - (e) Terry has written to the person who makes the bookings at the Emmanuel but she has denied that there were any problems and the room was clear.
  - (f) Kirsty is unable to provide catering for the Christmas party. Other options are Darfield Garden Centre and the sandwich shop in Greenfoot Lane, which is under new management.

### 6. Chair's report (Ann-Marie)

- (a) Kathie has confirmed she will be retiring from the committee at next year's AGM so we need to recruit a replacement urgently. Doris suggested we could ask BCVS and Barnsley Council to publicise an advert in their weekly bulletins.
- (b) The committee discussed whether we should continue with Ian McMillan as our President but it was felt that we may have difficulty in finding a replacement.
- (c) The committee ran through the Christmas Party checklist and agreed the action to be taken.
